ACT NOW: Urge the U.S. Senate to Address Patient Misidentification

In June, the US House of Representatives adopted an amendment striking language in the House FY20 Labor, Health and Human Services, Education (Labor-HHS) Appropriations bill that prohibits the US Department of Health and Human Services (HHS) from using federal funds to promulgate or adopt a unique patient identifier. Striking this language will give HHS the ability to evaluate a range of patient identification solutions that protect patient privacy and are cost-effective, scalable, and secure.

Now that a budget deal in Congress has materialized, we expect the US Senate to move quickly to consider the Senate FY20 Labor-HHS appropriations bill this fall. **Before Congress returns in September, we ask that you contact your US Senators via AHIMA's Advocacy Action Center to encourage them to remove this archaic ban.**

For nearly two decades, innovation and industry progress has been stifled due to broad interpretation of this language included in Labor-HHS bills since FY1999. More than that, without the ability of clinicians to correctly connect a patient with their medical record, lives have been lost and medical errors have needlessly occurred. These are situations that could have been entirely avoidable had patients been able to have been accurately identified and matched with their records. This problem is so dire that one of the nation's leading patient safety organizations, the ECRI Institute, named patient identification among the top ten threats to patient safety.

The absence of a consistent approach to accurately identifying patients has also resulted in significant costs to hospitals, health systems, physician practices, long-term post-acute care (LTPAC) facilities, and other providers, as well as hindered efforts to facilitate health information exchange. According to a 2016 study of healthcare executives, misidentification costs the average healthcare facility \$17.4 million per year in denied claims and potential lost revenue. More importantly, there are patient safety implications when data is matched to the wrong patient and when essential data is lacking from a patient's record due to identity issues. The 2016 National Patient Misidentification Report cites that 86 percent of respondents said they have witnessed or know of a medical error that was the result of patient misidentification.

Contact your US Senators today and urge them to strike this archaic ban from the Senate Labor, Health and Human Services, Education, and Related Agencies Appropriations Act of 2020.

IHIMA Board Bullets

The IHIMA Board of Directors met on Friday, August 23rd from 9:00 a.m. to 3:30 p.m. EST.

The following includes the highlights of the meeting:

- 1) The Board reviewed this year's Strategic Plan to make sure the 2019-2020 goals are being met within the designated timeframe. Everything is on track!
- 2) The Professional Development/Annual Meeting Committee reported the Fall Conference will be October 18th at King's Daughters in Madison, IN. More information will be coming soon! Also, the 2020 Annual Meeting is in the planning stages with agenda preparation, contacting speakers, and finalizing vendor booth/sponsorships.
- 3) The Legislative Committee reported on the Day at the State House in March 2020 with possible learning events on the legislative process prior to and on the day of the State House visit. There is continued work with the Indiana Hospital Association (IHA) regarding the Medical Record Charging Law. The committee is also considering providing webinars on the Medical Record Charging Law and Patient Matching. A committee member will be presenting at the CIHIMA meeting in October about the work the Legislative Committee is doing.
- 4) The Nominating Committee will be soliciting names for the 2020-2021 ballot. The ballot will include: President-Elect, Secretary, Treasurer, two (2) Delegates, and two (2) Nominating Committee members. The committee is working on updating the applications for the IHIMA Achievement Awards: Distinguished Member, Professional Achievement, and Rising Star.
- 5) The Delegates reported the AHIMA Bylaws are being reviewed. The proposed bylaws amendment will be voted on at the House of Delegates this month in Chicago.
- 6) The IHIMA Scholarship Application is currently being updated and will be open very soon. Check the IHIMA website to apply: <https://www.ihima.org/scholarship>. The application is due by November 15, 2019.
- 7) CIHIMA reported they will have a meeting on October 10th in Lafayette, IN. Registration begins at noon; the meeting starts at 12:30 pm EST. The cost is \$20 for members and free to students. The meeting is worth three (3) CEUs. More information will be sent to CIHIMA members soon!



Coding Corner - Red Flags for Myocardial Infarctions Coding and CDI

As many HIM professionals know, there are substantial “red flag” terms related to coding myocardial infarctions (MIs) and non-MI troponin elevation, which can cause considerable challenges for providers, coding professionals, and clinical documentation improvement (CDI) staff. Coding accuracy related to MI diagnosis affects a multitude of areas, including:

- Centers for Medicare and Medicaid Services quality claims-based measures
- Public health data tracking
- Physician comparisons
- Reimbursement
- Patient outcomes

With the release of the fourth universal definition of MIs and the implementation of type-specific MI codes released in October 2017, it has become increasingly important to have Type 1 MI, Type 2 MI, and Non-MI troponin elevation documented appropriately.¹ Vague or conflicting terms in documentation such as demand ischemia, demand mismatch, and troponin leak are common.
