ROLE OVERVIEW

The Nominating Committee plays a crucial role within IHIMA, responsible for shaping the future leadership of our organization and recognizing outstanding members.

Here's a snapshot of the core responsibilities that define this position:

• Executive Board Representation: Two Nominating Committee members are elected members of the Executive Board, providing a direct link between the committee and the organization's leadership.

• Attendance at Key Meetings: Nominating Committee members are required to attend both Executive Board meetings

- and Nominating Committee meetings, where they actively participate in discussions and decision-making.

 Nomination Review: The Nominating Committee solicits and reviews pominations for the Distinguished Member.
- Nomination Review: The Nominating Committee solicits and reviews nominations for the Distinguished Member, Professional Achievement, and Rising Star awards, subsequently making recommendations to the Executive Board.
- Recruitment of Volunteers: In addition to award nominations, the Nominating Committee also solicits volunteers for upcoming elections and other volunteer opportunities within IHIMA.



COMMITTEES AND RESPONSIBILITIES

In this critical role, Nominating Committee Members contribute to the organization in the following ways:

- Executive Board Meetings: As elected members of the Executive Board, they participate in meetings that shape the direction and policies of IHIMA.
- Nominating Committee Meetings: They actively engage in discussions and decisions that influence the selection of future leaders and award recipients within IHIMA

With no previous board experience required, this board position is a great way to initiate involvement with IHIMA's board. This role is a fantastic opportunity to help guide the future of IHIMA and recognize excellence within our community.

ELECTORAL PROCESS



The Nominating Committee Member position is an elected one, offering a one-year term of service. To be eligible for this role, candidates must be IHIMA Professional Members with AHIMA credentials in good standing.

What specific initiatives or projects have you been involved in as a board member, and how have they contributed to IHIMA's goals?

- Karen: Recruitment of board members and selection of IHIMA Award members have been the extent thus far of my involvement as a board member.
- Jessica: I am the designer of this spotlight series!
 The committee has collaborated on how to execute the series, and I've worked to design these newsletters to help potential new members learn more about our board positions.
